

2026 PHOTOGRAPHER/DVD LICENCE FORM



Persons wishing to be considered to take photographs or DVD footage on any ORCi track must complete this form.

- Fee for renewals £50.00 (before 31 December 2025 only)
- Fee for renewals/applications after this date £80.00

- Only persons aged over 18 years can apply for a Photographer/DVD licence.
- Please ensure the correct postage is used when sending your form, otherwise a surcharge will be applied.
- Have you completed the latest ORCi questionnaire? If not, your licence will not be issued until you have.
- Once your form has been received and accepted you will be issued with your Photographers Logbook, which you must have with you at all race meetings.

Wherever possible a licenced photographer/DVD operator must send images of meetings attended to the staging promoter within 72 hours.

The ORCi may also request images, and by signing this form you give authority for the ORCi to use your images as they see fit.

You must sign your logbook as confirmation that you comply with the health and safety requirements contained within it.

A licence does not automatically entitle the holder to complimentary admission, or access to restricted areas such as the infield - this must be an arrangement by prior agreement with the staging promoter.
